### Terms and Conditions

1. Return a signed copy of this Agreement and the Group Chairperson Instructions, along with your deposit no later than the Deposit Due Date shown above. If not received, the tee times reserved for the event will be released for general play.
2. Upon receipt of the signed Agreement, Instructions and deposit, the deposit will be applied in full to the actual total fees incurred on the day of the event. Total fees, less deposit, shall be paid in full on the day of play.
3. A final count of the total # of players must be confirmed more than seven (7) days prior to event with the **Tournament Coordinator. You will be responsible for payment of the players confirmed at this time.**
4. Northwood policy is to collect a deposit on all Group Outings in advance. 100% of the bill is due within 7 days of the event. Deposits are refundable if event is cancelled more 14 days prior prior to event.
5. **All food and beverage consumed on the golf course, practice areas, clubhouse and parking lot must be purchased from Northwood Restaurant.**

## Northwood Golf Club Policies and Rules

- \_\_\_\_\_All food and beverages to be consumed on the course must be purchased on the premises. Bringing your own food/beverages to the course is not permitted!
  
- \_\_\_\_\_All groups are expected to play at a pace consistent with the playing conditions and observe proper golf course etiquette and safety factors. All players must keep pace without undue delay. NWGC Marshals have the authority to move groups forward in the case of slow play and any group causing undue delay will be required to move ahead to a position immediately behind the group in front of them. No refunds will be given to groups which are moved forward.
  
- Each player must have a set of golf clubs.
  
- All players must adhere to the dress code. No cut-off shorts, swim wear, tank tops or bare chests permitted.
  
- Persons operating golf cars must possess a valid drivers' license. All spectators must ride in power carts; Only 2 persons and 2 set of clubs per golf car permitted at any time.
  
- Participants conduct is the responsibility of Group Outing Director attending event. Participants advised of improper conduct will be asked to leave the premises.
  
- No other discounts of any kind are valid for this event unless specified in writing and included in this agreement.
